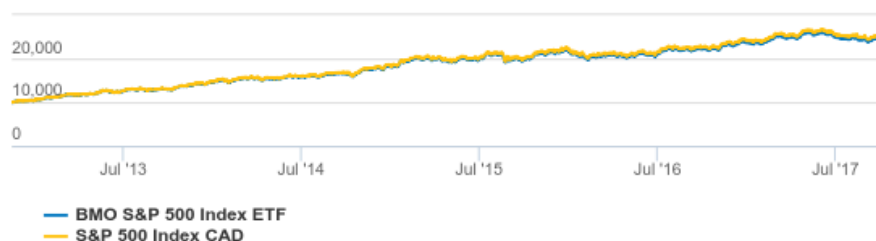
Benchmark Info

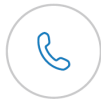
Sector Allocation
