## MATURITY BREAKDOWN (%)



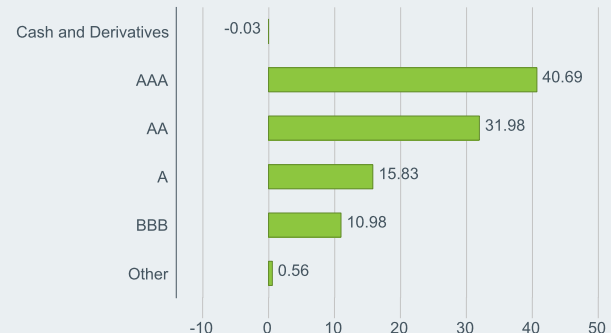
