MATURITY BREAKDOWN (%)



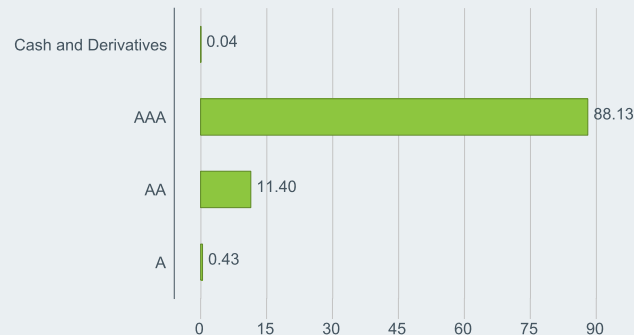
