DETAILS OF THE OFFERING

The Series DD Preferred Shares will have attached thereto the series provisions summarized below.

Dividends

Holders of Series DD Preferred Shares will be entitled to receive fixed cumulative preferential cash dividends of \$1.125 per share per annum, to accrue from the date of original issue, payable quarterly on the first day of March, June, September and December of each year, if, as and when declared by the Board of Directors. Assuming an issue date of May 15, 2013, the first dividend, if declared, will be payable September 1, 2013 in the amount of \$0.3360 per Series DD Preferred Share.

Redemption

The Series DD Preferred Shares will not be redeemable before September 1, 2018, but will be redeemable for cash on and after that date at the option of the Corporation, in whole at any time or in part from time to time, on not less than 30 days nor more than 60 days prior notice, at \$26.00 per share if redeemed during the 12 months commencing September 1, 2018, at \$25.75 per share if redeemed during the 12 months commencing September 1, 2020, at \$25.25 per share if redeemed during the 12 months commencing September 1, 2020, at \$25.25 per share if redeemed during the 12 months commencing September 1, 2021, and at \$25.00 per share if redeemed on and after September 1, 2022, in each case together with all accrued and unpaid dividends to but excluding the date of redemption.

The Corporation may redeem less than all of the then outstanding Series DD Preferred Shares at any time in such manner as is specified in the series provisions and is acceptable to the TSX.

Purchase for Cancellation

Subject to the provisions described under "Restrictions on Dividends and Retirement of Shares", the Corporation may at any time or times purchase for cancellation all or any part of the Series DD Preferred Shares on the open market, by private agreement or otherwise at the lowest price or prices at which in the opinion of the Board of Directors such shares are obtainable.

Creation or Issue of Additional Shares

So long as any Series DD Preferred Shares are outstanding the Corporation shall not, without the prior approval of the holders of the Series DD Preferred Shares given in the specified manner, create or issue any shares ranking prior to or on a parity with the Series DD Preferred Shares with respect to repayment of capital or payment of dividends, provided that the Corporation may without such approval, if all dividends then payable on the Series DD Preferred Shares shall have been paid, issue additional series of Series Second Preferred Shares of the Corporation ("Series Second Preferred Shares").

Restrictions on Dividends and Retirement of Shares

So long as any of the Series DD Preferred Shares are outstanding, the Corporation shall not:

- (a) declare or pay or set apart for payment any dividends (other than stock dividends in shares of the Corporation ranking junior to the Series DD Preferred Shares) on the Class A Shares or Class B Shares or any other shares of the Corporation ranking junior to the Series DD Preferred Shares with respect to payment of dividends,
- (b) call for redemption, purchase, reduce or otherwise pay off any shares of the Corporation ranking junior to the Series DD Preferred Shares with respect to repayment of capital or with respect to payment of dividends, or
- (c) call for redemption or purchase or reduce or otherwise pay off less than all the Series DD Preferred Shares and all the Series Second Preferred Shares and all other preferred shares ranking prior to or on a parity with the Series DD Preferred Shares then outstanding with respect to payment of dividends

unless all dividends up to and including the dividends payable on the last preceding respective dividend payment dates on the Series DD Preferred Shares and on the Series Second Preferred Shares and on all other preferred shares

ranking prior to or on a parity with the Series DD Preferred Shares with respect to payment of dividends then outstanding shall have been declared and paid or set apart for payment.

Rights on Liquidation

In the event of the liquidation, dissolution or winding-up of the Corporation, or other distribution of assets of the Corporation among its shareholders for the purpose of winding-up its affairs, the holders of the Series DD Preferred Shares shall be entitled to receive the amount paid up on such shares together with all accrued and unpaid cumulative preferential dividends thereon up to but excluding the date of payment or distribution (less any tax required to be deducted and withheld by the Corporation) before any amount shall be paid or any property or assets of the Corporation shall be distributed to the holders of any Class A Shares or Class B Shares or other shares ranking junior to the Series DD Preferred Shares. After payment to the holders of the Series DD Preferred Shares of the amounts so payable to them, they shall not be entitled to share in any further distribution of the property or assets of the Corporation. The Series Second Preferred Shares of each series rank equally with the Series Second Preferred Shares of every other series with respect to priority in payment of dividends and in the distribution of assets in the event of liquidation, dissolution or winding up of the Corporation.

Tax Election

The Series DD Preferred Shares will be "taxable preferred shares" as defined in the Tax Act. The terms of the Series DD Preferred Shares require the Corporation to make the necessary election under Part VI.1 of the Tax Act so that corporate holders of Series DD Preferred Shares will not be required to pay tax under Part IV.1 of the Tax Act on dividends received (or deemed to be received) on the Series DD Preferred Shares. See "Certain Canadian Federal Income Tax Considerations – Dividends".

Voting Rights

The holders of the Series DD Preferred Shares are not entitled to any voting rights or to receive notice of or to attend shareholders' meetings unless dividends on the Series Second Preferred Shares of any series are in arrears to the extent of eight quarterly dividends or four half-yearly dividends, as the case may be, whether or not consecutive. Until all arrears of dividends have been paid, holders of Series DD Preferred Shares will be entitled to receive notice of and to attend all shareholders' meetings at which directors are to be elected (other than separate meetings of holders of another class or series of shares) and to one vote in respect of each Series DD Preferred Share held.

Modification

The series provisions attaching to the Series DD Preferred Shares may be amended with the written approval of all the holders of the Series DD Preferred Shares outstanding or by at least two-thirds of the votes cast at a meeting of the holders of such shares duly called for that purpose and at which a quorum is present.

Business Day

If any day on which any dividend on the Series DD Preferred Shares is payable by the Corporation or on or by which any other action is required to be taken by the Corporation is not a business day, then such dividend shall be payable and such other action may be taken on or by the next succeeding day that is a business day.

DEPOSITORY SERVICES

Except as otherwise provided herein, the Series DD Preferred Shares will be issued in "book-entry only" form and must be purchased, transferred, converted or redeemed through participants (collectively, "Participants" and individually, a "Participant") in the depository service of CDS or its nominee. Each of the Underwriters is a Participant. On the closing of this offering, the Corporation will cause a global certificate or certificates representing the Series DD Preferred Shares to be delivered to, and registered in the name of, CDS or its nominee. Except as described below, no purchaser of Series DD Preferred Shares will be entitled to a certificate or other instrument from the Corporation or CDS evidencing that purchaser's ownership thereof, and no purchaser will be shown on the records maintained by CDS except through a book-entry account of a Participant acting on behalf of such purchaser. The Corporation understands that each purchaser of Series DD Preferred Shares will receive a

customer confirmation of purchase from the registered dealer from or through which the Series DD Preferred Shares are purchased in accordance with the practices and procedures of that registered dealer. The practices of registered dealers may vary, but generally customer confirmations are issued promptly after execution of a customer order. CDS will be responsible for establishing and maintaining book-entry accounts for its Participants having interests in the Series DD Preferred Shares. Reference in this prospectus supplement to a holder of Series DD Preferred Shares means, unless the context otherwise requires, the owner of the beneficial interest in the Series DD Preferred Shares.

If the Corporation determines, or CDS notifies the Corporation in writing, that CDS is no longer willing or able to discharge properly its responsibilities as depository with respect to the Series DD Preferred Shares and the Corporation is unable to locate a qualified successor, or if the Corporation at its option elects, or is required by law, to terminate the book-entry system, then Series DD Preferred Shares will be issued in fully registered and certificated form to the owners of the beneficial interests in such Series DD Preferred Shares or their nominees.

RATINGS

Credit ratings are intended to provide investors with an independent measure of the credit quality of an issue of securities and are indicators of the likelihood of payment and of the capacity and willingness of an issuer to meet its financial commitment on a security in accordance with the terms of the security.

The Series DD Preferred Shares of the Corporation are rated Pfd-2 (high) with a stable trend by DBRS Limited ("DBRS") and P-2 (High) with a stable outlook by Standard & Poor's, a division of The McGraw-Hill Companies, Inc. ("S&P").

A Pfd-2 rating by DBRS is the second highest of six categories granted by DBRS. Preferred shares rated Pfd-2 are of satisfactory credit quality. Protection of dividends and principal is substantial, but earnings, the balance sheet, and coverage ratios are not as strong as higher rated companies. Each rating category is denoted by the subcategories "high" and "low". The absence of either a "high" or "low" designation indicates the rating is in the "middle" of the category.

A P-2 rating by S&P is the second highest of eight categories S&P uses in its Canadian preferred share rating scale. A security rated P-2 exhibits adequate protection parameters. However, adverse economic conditions or changing circumstances are more likely to lead to a weakened capacity of the issuer to meet its financial commitment on the security. A "high" or "low" designation shows relative standing within a rating category. The absence of either a "high" or "low" designation indicates the rating is in the "middle" of the category.

A security rating is not a recommendation to buy, sell or hold securities and may be subject to revision or withdrawal at any time by the rating organization.

The Corporation will make payments to DBRS and S&P in connection with the assignment of the ratings to the Series DD Preferred Shares. In addition, the Corporation has made payments in respect of certain other services provided to the Corporation by each of DBRS and S&P during the last two years.

PLAN OF DISTRIBUTION

Pursuant to an underwriting agreement dated effective April 30, 2013 between the Corporation and the Underwriters (the "Underwriting Agreement"), the Corporation has agreed to sell and the Underwriters have severally agreed to purchase on May 15, 2013, or on such later date as may be agreed upon, but not later than May 22, 2013, subject to the terms and conditions stated therein, all but not less than all of the Series DD Preferred Shares at a price of \$25.00 per share payable in cash to the Corporation against delivery of such Series DD Preferred Shares. The obligations of the Underwriters under the Underwriting Agreement may be terminated upon the occurrence of certain stated events. The Underwriters are, however, obligated to take up and pay for all of the Series DD Preferred Shares if any Series DD Preferred Shares are purchased under the Underwriting Agreement. The offering price of the Series DD Preferred Shares was determined by negotiation between the Corporation and the Underwriters. The Underwriters have agreed not to offer, sell or deliver any Series DD Preferred Shares in the United States or to any U.S. persons.

The Underwriters may not, throughout the period of distribution, bid for or purchase Series DD Preferred Shares. The foregoing restriction is subject to certain exceptions, on the condition that the bid or purchase not be engaged in

for the purpose of creating actual or apparent active trading in or raising the price of the Series DD Preferred Shares. These exceptions include a bid or purchase permitted under the Universal Market Integrity Rules administered by the Investment Industry Regulatory Organization of Canada relating to market stabilization and passive market-making activities and a bid or purchase made for and on behalf of a customer where the order was not solicited during the period of distribution. The Corporation has been advised that, in connection with this offering and subject to the foregoing, the Underwriters may over-allot or effect transactions which stabilize or maintain the market price of the Series DD Preferred Shares at a level above that which might otherwise prevail in the open market. Such transactions, if commenced, may be discontinued at any time.

The Underwriters propose to offer the Series DD Preferred Shares initially at the initial public offering price specified on the cover page of this prospectus supplement. After a reasonable effort has been made to sell all of the Series DD Preferred Shares at the initial public offering price, the Underwriters may subsequently reduce and thereafter change, from time to time, the price at which the Series DD Preferred Shares are offered to an amount not greater than \$25.00 per share. Should such a price reduction occur, the compensation realized by the Underwriters will be decreased by the amount that the aggregate price paid by purchasers for the securities is less than the price paid by the Underwriters to the Corporation. Notwithstanding any such reduction by the Underwriters, the proceeds received by the Corporation will not be affected.

Four of the Underwriters, RBC Dominion Securities Inc., BMO Nesbitt Burns Inc., TD Securities Inc. and Scotia Capital Inc., are subsidiaries of Canadian chartered banks, which have extended credit facilities to the Corporation and certain of its affiliates. Accordingly, under certain circumstances, the Corporation may be considered a "connected issuer" of the Underwriters under applicable Canadian securities legislation. The aggregate amount of such credit facilities available to the Corporation and its affiliates is approximately \$1.86 billion, of which approximately \$174.7 million was drawn as of March 31, 2013. These facilities include term facilities, demand facilities and overdraft facilities made available to the Corporation and its affiliates. These facilities also include non-recourse debt of the Corporation's affiliates for which the lender's recourse in the event of default is limited to the business and assets of the project in question and to the affiliates' equity therein. The Corporation and its affiliates are in compliance with the terms of these credit facilities. Since March 31, 2013, there have been no material changes to the amounts owing under these facilities. The decision of each Underwriter to participate in this offering was made independently of its bank parent. The net proceeds from the offering will not be used to repay amounts outstanding under the credit facilities of the Corporation. See "Use of Proceeds".

The TSX has conditionally approved the listing of the Series DD Preferred Shares. Listing of the Series DD Preferred Shares is subject to the Corporation fulfilling all of the requirements of the TSX on or before July 31, 2013 including distribution of these securities to a minimum number of public securityholders.

ELIGIBILITY FOR INVESTMENT

In the opinion of Bennett Jones LLP, counsel to the Corporation, and of Blake, Cassels & Graydon LLP, counsel to the Underwriters, subject to the provisions of any particular plan, the Series DD Preferred Shares offered hereby, if issued on the date hereof, generally would be qualified investments under the Tax Act and the regulations thereunder (the "Regulations") for a trust governed by a registered retirement savings plan ("RRSP"), a registered retirement income fund ("RRIF"), a registered education savings plan, a registered disability savings plan, a deferred profit sharing plan, or a tax-free savings account ("TFSA").

Notwithstanding that the Series DD Preferred Shares may be qualified investments for a trust governed by an RRSP, RRIF or a TFSA, the annuitant under an RRSP or RRIF or the holder of a TFSA may be subject to a penalty tax if such Series DD Preferred Shares are "prohibited investments" for the RRSP, RRIF or TFSA within the meaning of the Tax Act. The Series DD Preferred Shares will be a "prohibited investment" if the annuitant under the RRSP or RRIF, or the holder of the TFSA, as the case may be, (i) does not deal at arm's length with the Corporation for purposes of the Tax Act; (ii) has a "significant interest" (as defined in the Tax Act) in the Corporation; or (iii) has a "significant interest" in any corporation, partnership or trust with which the Corporation does not deal at arm's length for purposes of the Tax Act. The Department of Finance (Canada) released draft legislation on December 21, 2012 (the "December 2012 Proposals") that proposes to eliminate the condition in (iii) above.

Prospective investors who intend to hold Series DD Preferred Shares in their RRSP, RRIF or TFSA should consult their own tax advisors regarding whether the Series DD Preferred Shares will be a qualified

investment and not be a prohibited investment based on their particular circumstances, including with respect to the December 2012 Proposals.

USE OF PROCEEDS

The estimated net proceeds (after deducting the Underwriters' Fee) to be received by the Corporation from the sale of the Series DD Preferred Shares are \$218,250,000 assuming that no Series DD Preferred Shares are sold to certain institutions. The net proceeds will be added to the general funds of the Corporation to be used for capital expenditures, to repay existing indebtedness and for other general corporate purposes.

EARNINGS COVERAGE RATIO

The earnings coverage ratios for the 12 month periods ended December 31, 2012 and March 31, 2013 have been calculated based on information contained within the Corporation's financial statements for the related periods which were prepared in accordance with Canadian generally accepted accounting principles, which is within the framework of International Financial Reporting Standards. The earnings coverage ratios set out below do not purport to be indicative of earnings coverage ratios for any future periods. The earnings coverage ratios are equal to net earnings before borrowing costs on all financial liabilities ("borrowing costs") and income taxes divided by borrowing costs (including capitalized interest) and the Corporation's aggregate dividend requirements.

The Corporation's dividend requirements on all of its preferred shares, after giving effect to the issue of the Series CC Preferred Shares and Series DD Preferred Shares and adjusted to a before-tax equivalent using an effective income tax rate of 21.4%, amounted to \$92 million for the 12 months ended December 31, 2012. The Corporation's borrowing cost requirements (including capitalized interest) amounted to \$319 million for the 12 months ended December 31, 2012. The Corporation's earnings before borrowing costs and income taxes for the 12 months ended December 31, 2012, were \$997 million, which was 2.4 times Corporation's aggregate dividend and borrowing cost requirements (including capitalized interest), after giving effect to the issue of the Series CC Preferred Shares and Series DD Preferred Shares.

The Corporation's dividend requirements on all of its preferred shares, after giving effect to the issue of the Series CC Preferred Shares and the Series DD Preferred Shares and adjusted to a before-tax equivalent using an effective income tax rate of 21.6%, amounted to \$91 million for the 12 months ended March 31, 2013. The Corporation's borrowing cost requirements (including capitalized interest) amounted to \$324 million for the 12 months ended March 31, 2013. The Corporation's earnings before borrowing costs and income taxes for the 12 months ended March 31, 2013, were \$989 million, which was 2.4 times Corporation's aggregate dividend and borrowing cost requirements (including capitalized interest), after giving effect to the issue of the Series CC Preferred Shares and the Series DD Preferred Shares.

RISK FACTORS

A prospective purchaser of Series DD Preferred Shares should carefully consider the following investment considerations before making a decision to purchase Series DD Preferred Shares, as well as the other information contained in this prospectus supplement and the documents incorporated by reference herein, including, in particular, the information described under the headings "Utilities - Utilities Business Risks", "Energy - Energy Business Risks", "ATCO Australia - ATCO Australia Business Risks" and "Risk Management and Financial Instruments" in the Corporation's management's discussion and analysis for the year ended December 31, 2012.

There is no market through which the Series DD Preferred Shares may be sold and purchasers may not be able to resell Series DD Preferred Shares purchased under this prospectus supplement. This may affect the pricing of the Series DD Preferred Shares in the secondary market, the transparency and availability of trading prices, the liquidity of the Series DD Preferred Shares and the extent of issuer regulation.

Prevailing yields on similar securities will affect the market values of the Series DD Preferred Shares. Assuming all other factors remain unchanged, the market value of the Series DD Preferred Shares will decline as prevailing yields for similar securities rise and will increase as prevailing yields for similar securities decline. Real or anticipated changes in credit ratings on the Series DD Preferred Shares may affect the market value of the Series DD Preferred Shares.

The Series DD Preferred Shares are equity capital of the Corporation which rank equally with other preferred shares of the Corporation in the event of an insolvency or winding-up of the Corporation. If the Corporation becomes insolvent or is wound up, the Corporation's assets must be used to pay liabilities and other debt before payments may be made on the Series DD Preferred Shares and other preferred shares.

Dividends on the Series DD Shares are payable at the discretion of the Board of Directors. The Corporation may not declare or pay a dividend if there are reasonable grounds for believing that (a) the Corporation is, or would after the payment be, unable to pay its liabilities as they become due, or (b) the realizable value of the Corporation's assets would thereby be less than the aggregate of its liabilities and stated capital of its outstanding shares.

CERTAIN CANADIAN FEDERAL INCOME TAX CONSIDERATIONS

In the opinion of Bennett Jones LLP, counsel to the Corporation, and Blake, Cassels & Graydon LLP, counsel to the Underwriters, (collectively "Counsel") the following summary, as of the date hereof, describes the principal Canadian federal income tax considerations generally applicable under the provisions of the Tax Act to a prospective purchaser of Series DD Preferred Shares pursuant to the Prospectus who, at all relevant times, for the purposes of the Tax Act, is (or is deemed to be) resident in Canada, deals at arm's length with and is not affiliated with the Corporation and holds the Series DD Preferred Shares as capital property (a "Holder"). Generally, the Series DD Preferred Shares will be considered to be capital property to a Holder provided the Holder does not hold the shares in the course of carrying on a business of trading or dealing in securities and has not acquired them in one or more transactions considered to be an adventure or concern in the nature of a trade. Certain Holders who might not otherwise be considered to hold their Series DD Preferred Shares as capital property may, in certain circumstances, be entitled to have their Series DD Preferred Shares and every other "Canadian security", as defined in the Tax Act, owned by the Holder in the taxation year of the election and every subsequent taxation year, treated as capital property by making the irrevocable election permitted by subsection 39(4) of the Tax Act. Holders who do not hold their Series DD Preferred Shares as capital property should consult their own tax advisers with respect to their own particular circumstances. This summary assumes that the Series DD Preferred Shares will be listed on a designated stock exchange in Canada under the Tax Act (which currently includes the TSX) at all relevant times.

This summary is not applicable to: (i) a Holder that is a "financial institution", as defined in the Tax Act for the purpose of the "mark-to-market" rules; (ii) a Holder, an interest in which would be a "tax shelter investment", as defined in the Tax Act; (iii) a Holder that is a "specified financial institution" or a "restricted financial institution", each as defined in the Tax Act; or (iv) a Holder which has made a "functional currency" election under the Tax Act to determine its Canadian tax results in a currency other than Canadian currency. Any such Holder should consult its own tax advisors with respect to an investment in the Series DD Preferred Shares.

This summary is based upon the current provisions of the Tax Act, the Regulations, all specific proposals to amend the Tax Act and the Regulations publicly announced by or on behalf of the Minister of Finance (Canada) prior to the date hereof (the "Proposals"), existing case law and Counsels' understanding of the current written administrative and assessing policies and practices of the Canada Revenue Agency. This summary assumes the Proposals will be enacted in the form proposed, however, no assurance can be given that the Proposals will be enacted in their current form, or at all. This summary is not exhaustive of all possible Canadian federal income tax considerations and, except for the Proposals, does not take into account or anticipate any changes in law, whether by legislative, governmental or judicial decision or action, nor does it take into account any provincial, territorial or foreign income tax legislation or considerations.

This summary is of a general nature only and is not intended to be, nor should it be construed to be, legal or tax advice to any particular Holder of Series DD Preferred Shares. No representations are made with respect to the income tax consequences to any particular Holder. Consequently, prospective Holders should consult their own tax advisers with respect to their particular circumstances for advice with respect to the tax consequences to them of acquiring, holding and disposing of the Series DD Preferred Shares including the application and effect of the income and other tax laws of any country, province, state or local tax authority.

Dividends

Dividends (including deemed dividends) received (or deemed to be received) on the Series DD Preferred Shares by an individual (other than certain trusts) will be included in the individual's income and will be subject to the gross-

up and dividend tax credit rules normally applicable to taxable dividends received from taxable Canadian corporations. Individuals are entitled to an enhanced gross-up and dividend tax credit in respect of "eligible dividends" received from taxable Canadian corporations, such as the Corporation, if such dividends have been designated as eligible dividends by the Corporation at or before the time of payment. By notice in writing on the Corporation's website, the Corporation has designated that all taxable dividends paid on its shares on or after January 1, 2006 will be "eligible dividends" within the meaning of the Tax Act unless otherwise indicated. Management of the Corporation has advised counsel that the Corporation anticipates that the dividends paid to holders of the Series DD Preferred Shares will be designated as eligible dividends.

Dividends received by a Holder who is an individual (other than certain trusts) may give rise to a liability for alternative minimum tax under the Tax Act.

Dividends (including deemed dividends) received on the Series DD Preferred Shares by a Holder that is a corporation will be included in computing the Holder's income and will generally be deductible in computing the Holder's taxable income. A "private corporation", as defined in the Tax Act, or any other corporation controlled (whether by reason of a beneficial interest in one or more trusts or otherwise) by or for the benefit of an individual (other than a trust) or a related group of individuals (other than trusts), will generally be liable to pay a 33 1/3% refundable tax under Part IV of the Tax Act on dividends received (or deemed to be received) on the Series DD Preferred Shares to the extent such dividends are deductible in computing its taxable income.

The Series DD Preferred Shares will be "taxable preferred shares" as defined in the Tax Act. The terms of the Series DD Preferred Shares require the Corporation to make the necessary election under Part VI.1 of the Tax Act so that corporate Holders will not be subject to tax under Part IV.1 of the Tax Act on dividends received (or deemed to be received) on the Series DD Preferred Shares.

Dispositions

A Holder who disposes of or is deemed to dispose of Series DD Preferred Shares (on the redemption of such shares or otherwise) will generally realize a capital gain (or sustain a capital loss) to the extent that the Holder's proceeds of disposition, net of any reasonable costs of disposition, exceed (or are less than) the adjusted cost base of such shares to the Holder. The amount of any deemed dividend arising on the redemption, acquisition or cancellation by the Corporation of Series DD Preferred Shares will generally not be included in computing the Holder's proceeds of disposition for the purposes of computing the capital gain (or capital loss) arising on the disposition of such Series DD Preferred Shares. See "Redemption" below. If the Holder is a corporation, any capital loss arising on a disposition of a Series DD Preferred Share may, in certain circumstances, be reduced by the amount of any dividends, including deemed dividends, which have been received on the Series DD Preferred Share. Analogous rules apply to a partnership or trust of which a corporation, partnership or trust is a member or beneficiary.

Generally, one-half of any capital gain realized in a taxation year will be included in computing the Holder's income in that taxation year as a taxable capital gain and, generally, one-half of any capital loss realized in a taxation year (an "allowable capital loss") must be deducted from the taxable capital gains realized by the Holder in the same taxation year, in accordance with the rules contained in the Tax Act. Allowable capital losses in excess of taxable capital gains realized by a Holder in a particular taxation year may be carried back and deducted in any of the three preceding taxation years or carried forward and deducted in any subsequent taxation year against net taxable capital gains realized by the Holder in such taxation year, subject to and in accordance with the rules contained in the Tax Act. Capital gains realized by an individual may give rise to a liability for alternative minimum tax under the Tax Act. Taxable capital gains of a "Canadian-controlled private corporation", as defined in the Tax Act, may be subject to an additional refundable tax at a rate of 6%%.

Redemption

If the Corporation redeems Series DD Preferred Shares or otherwise acquires or cancels Series DD Preferred Shares (other than by a purchase by the Corporation of the shares in the open market in the manner in which shares are normally purchased by any member of the public in the open market), the Holder will be deemed to have received a dividend equal to the amount, if any, paid by the Corporation in excess of the paid-up capital (as determined for purposes of the Tax Act) of such shares at such time. Generally, the difference between the amount paid by the Corporation and the amount of the deemed dividend will be treated as proceeds of disposition for purposes of

computing the capital gain or capital loss arising on the disposition of such shares. See "Dispositions" above. In the case of Holder that is a corporation, it is possible that in certain circumstances all or part of any such deemed dividend may be treated as proceeds of disposition and not as a dividend.

LEGAL MATTERS

Certain legal matters relating to the offering will be passed upon by Bennett Jones LLP for the Corporation and by Blake, Cassels & Graydon LLP for the Underwriters. As at the date hereof, partners and associates of Bennett Jones LLP and of Blake, Cassels & Graydon LLP, as a group, beneficially owned, directly or indirectly, less than 1% of any class of securities of the Corporation. R.T. Booth, a partner of Bennett Jones LLP, is a director of the Corporation and of ATCO Ltd., which is a publicly traded affiliate of the Corporation.

TRANSFER AGENT AND REGISTRAR

The transfer agent and registrar for the Series DD Preferred Shares is CIBC Mellon Trust Company at its principal office in Toronto.

STATUTORY RIGHTS OF WITHDRAWAL AND RESCISSION

Securities legislation in certain of the provinces of Canada provides purchasers with the right to withdraw from an agreement to purchase securities. This right may be exercised within two business days after receipt or deemed receipt of a prospectus and any amendment. In several of the provinces, the securities legislation further provides a purchaser with remedies for rescission or, in some jurisdictions, revisions of the purchase price or damages if the prospectus and any amendment contains a misrepresentation or is not delivered to the purchaser, provided that the remedies for rescission, revision of the price or damages are exercised by the purchaser within the time limit prescribed by the securities legislation of the purchaser's province. The purchaser should refer to any applicable provisions of the securities legislation of the purchaser's province for the particulars of these rights or consult with a legal adviser.
